In the Field...

Conducting A Records Search

f you walk into the clerk and recorder's office of almost any county in Montana and ask if a particular road is a county road, you might find it difficult to get a definite answer. Right-of-way professionals in Montana face this problem frequently, and the situation is probably the same in other states as well.


Some of the existing records have never been researched to determine where the rights of way are located. If a road book has been maintained, or easements were signed by the landowner and duly recorded, then the information should be available in the clerk and recorder's office. Other records, however, may be stored in annexes, basements, attics and sometimes in private homes. These records often have not been compiled, and may take considerable "leg work" to uncover.

Some recent court cases in Montana required evidence to support a "prescriptive easement." During the course of this research, evidence per-

taining to other roads was discovered, but no one bothered to document it. Anyone who needs that information would have to repeat the same steps over again.

Members of IRWA Chapter 45 decided to take an active role in resolving this problem. The chapter formed a committee consisting of four IRWA members. The committee went before groups associated with access issues to clarify the problem and establish a network of support. A presentation made at the annual meeting of the Montana Clerk and Recorders Association prompted their full support and the inclusion of three clerks and recorders on the committee.

Presentations were also made to the Montana Association of Registered Land Surveyors and to the Montana Association of County Officials. These groups were very supportive and agreed that it was a job that needed doing. The governor's Natural Resource Council on Access



to public lands for recreational use.

The committee established the goals of identifying all county roads documented (by dedication, grant or condemnation) in the state of Montana, and of presenting the information in a form accessible to the public, to be maintained by the counties. An emphasis would be placed on collecting information from commissioners' proceedings and records in county offices, annexes and wherever they may be found.

Volunteers are now working in three county offices to gather the information. Four other counties have agreed to provide expenses for volunteers to work in their offices. When the work in these counties is done, the information will be analyzed and

- The public, through clarification of public access in general
- Property owners and prospective buvers, through awareness of access rights and potential access problems on their properties
- The county, through reduction of administrative confusion and research costs


