Right of Way Professionals Gathered in Toronto, Ontario, for IRWA's "Where the World Meets" Education Conference

IRWA's 51st Annual International Education Conference held on June 13-16, 2005 in Toronto, Ontario, was an overwhelming success. More than 1,000 registrants attended the annual event and engaged in educational, motivational and networking sessions with other right of way professionals from around the world, including representatives from Japan, Korea and South Africa.

Hosted by Canada's Pioneer Chapter 29, IRWA's 51st Annual International Education Conference provided right of way professionals with unparalleled learning and networking opportunities. Over 55 educational sessions were presented during the four-day program, enabling attendees

> to learn about best practices, share project challenges and hear solutions from the industry's leading professionals.




#### 2005 - 2006 International President
