## What, Why and How for COPs

*The following is an excerpt from the “Guide to Cultivating IRWA Communities of Practice.”*

In 2013, IRWA began restructuring a number of International Committees—namely Relocation Assistance, Valuation, Asset Management, Environment and Survey and Engineering—into Communities of Practice (CoPs). By definition, a CoP is a group of people who share a passion for something that they do, and who interact regularly to learn how to do it better. It is through the process of sharing information and experiences with the group that the members learn from each other, and have an opportunity to develop themselves personally and professionally. The primary purpose of a CoP is to increase organization performance and member value. IRWA CoPs are designed to provide peer-to-peer learning opportunities that are complementary to our traditional education course offerings and publications. Every IRWA member is welcomed and encouraged to be a participant in one or all of the CoPs, and non-members are also welcome to join in the discussions. Membership in a CoP is free and participation is voluntary.

### Transitioning from a Committee to a Community of Practice:

IRWA’s International Discipline Committees historically focused on committee administration, supporting IRWA’s Annual Conference with educational sessions, as well as a limited discussion on current issues. Member participation was limited to the appointed chapter and region representatives, though the general membership was welcome to meetings and events if they wished to participate in the discussions.

The Discipline CoP will allow all members to easily participate in topic discussions. IRWA CoPs are focused on the member and the social structure that enables them to learn with and from each other. Participation will be achieved with teleconferencing and in-person meetings. The CoPs still have some administrative duties by supporting the Industry Committees, but the main focus is to engage the general membership. The CoP should entice the members to talk about their experiences and share with others how they were successful. The table below provides a few examples of activity categories.

Activity Categories	Example Topics and Questions
Problem-solving	How can we best reach out to our Chapter agency members? Let’s brainstorm some ideas; I’m stuck.
Requests for information	Where can I find the URA regulations on the FHWA website?
Seeking experience	Has anyone dealt with a displacee in this situation?
Coordination and synergy	How can we share this topic with all of the industry committees?
Discussing developments	What is the best way to educate members on the new FERC regulations?
Documentation projects	Who has implemented the new Turbo Relocation software?
Visits	That is a really interesting transit project; let’s plan a field trip for the Chapter.
Reusing assets	Who has an outline to write a new course?
