TAYLOR SASS

Taylor Sass was the very first Young Professional to be selected to serve on the RWIEF. Being the first, Taylor shared her experience with us.

As the first YP Trustee, I was timid in the beginning to share my thoughts on anything. Quickly, I realized the RWIEF's openness to hear my viewpoints. I was overwhelmed by their interest and felt part of the team. I understand that I had plenty of perspective to offer and found a confidence in myself. It was an incredible experience and I encourage Young Professionals that are looking for an opportunity to gain leadership skills to consider this role. I am beyond grateful to have had the opportunity.

How has the RWIEF impacted your career?

Being a YP Trustee taught me the general working functions and legalities of an actual foundation. Before sitting in the position, being a "Trustee" on a Board of Trustees for an International Foundation sounded incredibly intimidating and I was unsure what I could offer for the good of the Foundation. The YP Trustee position is an incredible way for Young Professionals to understand what the functions of a Board of Directors are and the processes and procedures involved. Being a YP Trustee on the RWIEF gave me the experience and knowledge required to accept a position on another Board of Directors/Trustees and has equipped me, I'm sure, for the rest of my career.

Secondly, the position taught me how to be a responsible steward and guardian of the Foundation's assets. I learned to understand the impact of the RWIEF and all the different opportunities that its funding affords. You realize that the Foundation can only exist because of its donors and the Trustees are responsible for whatever decisions are made. It is an incredible responsibility, but a critical notion to learn.

Being on the Foundation, what have you learned?

I learned the purpose of the Foundation and its function as it relates to funding educational programs and curriculums. Before being on the Foundation, I had no idea who funded IRWA Course Development, and I ignorantly just thought it existed. Without continuing the advancement of our education, our profession cannot progress. I learned that RWIEF plays a vital role in shaping the coursework of our education and it is a responsibility not taken lightly. Every decision is weighted, researched and carefully discussed. I believe the donors of the Foundations can be incredibly proud of the decisions made by the Board of Trustees.

What is your favorite part about the RWIEF?

My favorite part of being a YP Trustee are the relationships with the Board of Directors Members on the Foundation and the lessons they taught me. I have the utmost respect for those individuals who selflessly give their time to this cause. The entire Board was beyond welcoming to this new YP Trustee position and equally as eager to hear my viewpoint on numerous issues. I felt like I found my professional voice and they wanted to hear me.

Brett was the second Young Professional selected to serve on the Foundation.

How has the RWIEF impacted your career?

The Right of Way International Education Foundation has impacted my career by expanding my network, giving me the opportunity to learn and work on new projects as well as putting me in a position to utilize leadership skills. My experience on the RWIEF showed me that a passionate team united around a common goal can accomplish great things. This influenced me to get involved in other areas of the right of way industry, in addition to exploring new opportunities in my professional life.

What has it meant to you to be a Trustee of the RWIEF?

Trustees on the RWIEF are nominated and selected by the Board of Trustees. Having sat on the Board for three years, I know that each year a very deserving and talented group of individuals are considered for the position.
