**To ascertain and weigh all of the facts** relative to real properties in making an appraisal thereof, using the best and most approved methods of determining the just and fair market value.

**To conduct ourselves in the most ethical and competent manner** when testifying as an expert witness in court as to the market value of the real properties, thus meriting confidence in our knowledge and integrity.

**To accept our full share of responsibility** in constructive public service to community, state and nation.

**To strive to attain and to express a sincerity of character** that shall enrich our human contacts, ever aiming toward that ideal - "The Practice of the Golden Rule."

This charge is being led by Committee Chair, Bill Dee and Committee Vice-Chair Theresa Brennan. You can expect a complete report in June when we meet in Seattle for our International Education Conference.

I know you will also enjoy the conference's SR/WA Breakfast keynote speaker, Michael Josephson, founder of the Josephson Institute of Ethics. Michael is a global leader on the topic, and the Josephson Institute's Character Counts program has been chosen as this year's Charity of Choice. Character Counts is a school-based program that promotes the Josephson Institute's Six Pillars of Character to students worldwide. His six pillars include being trustworthy, treating others with respect, being responsible, treating others fairly, acting compassionate and caring, and being a good citizen. These pillars mesh well with our Code of Ethics, and his presentation is sure to be very illuminating.

Maintaining an environment of strong ethics is everyone's responsibility, and you can expect to see much more on this important topic going forward. As right of way professionals, we take our work seriously, and our commitment to ethics is no exception. And in the spirit of keeping our ethics at a high level, it never hurts to reread our Code and remind ourselves of the reasoning behind our actions.
